Tennis ball/trophies provided by STA. Tournament matches best 2 of 3 sets with regular ad scoring. Official USTA rules enforced. Absent agreement of players prior to commencement of match, if one set all, in lieu of 3rd set, a first to 10 super tiebreak will be played.
